



WAGNER CONSTRUCTION SCHEDULE

- Oct 2022 Set up security for Staging at Town Water Shop Yar
 - Establish Additional Staging in Dec 2022 Early 2023
- Oct/Nov 2022 Relocate existing 8,000 Gallon Tank
- Nov 2022 New Tank Access Construction
- Nov/Dec 2022 (depending on weather) Pre-Drilling for Blasting Assessment
- Apr/May 2023 Complete Access to New Tank Site
- Jun-Aug 2023 180,000 Gallon Storage Tank
- Sept-Oct 2023 Booster Pump Station
- Nov 2023-Oct 2024 Distribution System Main and Services Construction




WHAT TO EXPECT DURING CONSTRUCTION

- Two construction crews
 - one installing the new main, one reconnecting service lines immediately behind the main crew
 - Distribution Main Construction Completed in 200-foot Sections
- Website with weekly updates and a 3week look ahead
- Door hangers to notify you at home when work is schedule in your area



SERVICE LINES



NOTES:

- 1. NO CHANGE TO WATER SERVICE LOCATION.
- WATER SERVICE NOT LOCATED. COORDINATE WITH HOMEOWNER FOR LOCATION OF EXIST SERVICE LINE.
- WATER SERVICE TIE-IN LOCATION OUTSIDE OF ROW. TOWN HAS A TEMPORARY PROPERTY BLANKET EASEMENT.
- 4. COORDINATE WITH HOMEOWNER FOR LOCATION OF NEW SERVICE LINE.
- 5. TOWN HAS A PERMANENT AND TEMPORARY PROPERTY EASEMENT.
- 6. NO EXISTING SERVICE OR NEW SERVICE.
- 7. THE WATERLINE IS WITHIN THE EXISTING ROADWAY. THE ROW/PROPERTY LINES ARE TAKEN FROM THE LARIMER COUNTY GIS PLATFORM AND ARE APPROXIMATE.
